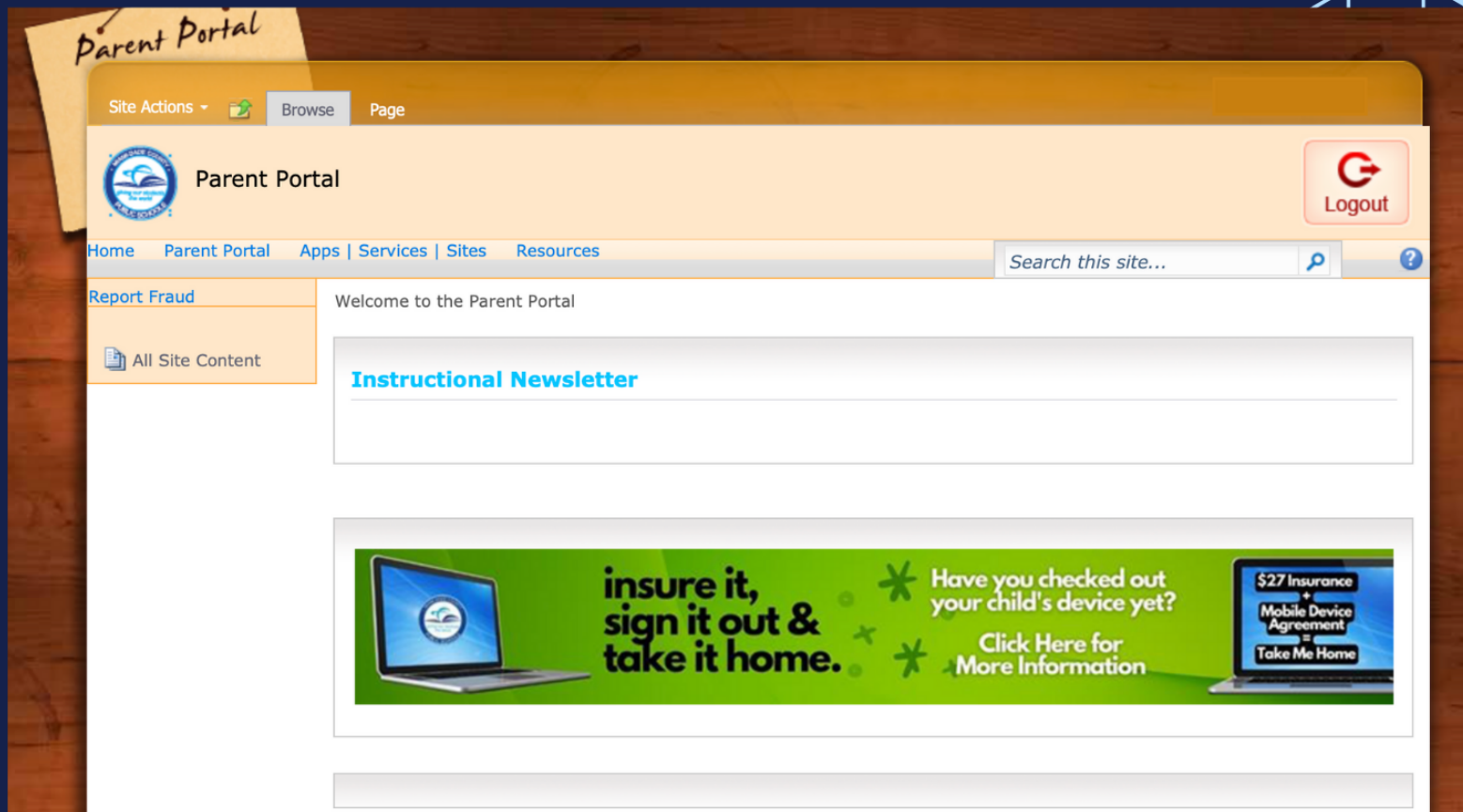

STEP 1: INSURE IT

In order to safeguard your device, we encourage that you purchase insurance for your device. Don't worry, you can purchase the plan now and once you have your device checked out to you, you can return to the portal to input the Serial Number and Model Number to finalize your insurance plan. The cost of the insurance plan is often 18 times less the price of a total replacement. It's a wise investment!

STEP 2: SIGN IT OUT

Parents will need to sign the Mobile Device Agreement form. You can do this simply by clicking below and providing the Student ID and Parent Email/Phone OR by clicking on the Mobile Device Agreement icon in the M-DCPS Mobile App. Once signed, the school can immediately check out the device to your student.

8. **Release of Liability.** Parent and the Student, including their heirs and assigns agree that they will release, forever discharge, indemnify, defend, and hold M-DCPS harmless from any and all claims arising from the Student's or Parent's use, misuse, or possession of the mobile device issued to the Student pursuant to this Agreement including but not limited to any and all damages whatsoever kind or nature.

9. **Survivorship, Governing Law and Venue.** Those provisions which by their nature are intended to survive the expiration, cancellation or termination of this Agreement. This Agreement shall be governed by, and construed in accordance with the laws of the State of Florida venue for any claim shall lie exclusively in a court of competent jurisdiction in Miami-Dade County. All parties shall be responsible for their own attorneys' fees and costs. Nothing herein shall be construed as consent by an agency or political subdivision of the State of Florida to be sued by third parties in any matter arising out of any contract.

Student and parent further acknowledge that this agreement represents the complete understanding and agreement between the school board (M-DCPS) and the parent and student with respect to the subject matter hereof. No other representations, stipulations, agreement, or understanding, whether oral or in writing shall be valid or enforceable or have any binding effect unless contained in this agreement. This agreement may not be changed, amended, or modified without the express written approval of the school board (M-DCPS). Any change, modification, or amendment to this agreement approved by the school board must be in writing.

STEP 3: PICK IT UP

Students should check with the main office at their school and ask to speak with the school's Asset Manager. The Asset Manager will be able to verify that insurance has been paid (you might want to take proof of insurance just to make things move faster) and that the Mobile Device Agreement has been signed! Pick up your device with the charger. Remember to log in once at school before taking the device home!



STEP 4: CONFIRM & TAKE IT HOME

You will receive a receipt via your student email once you have checked out your device. Confirm that the device provided to you matches the information in the receipt and keep this receipt in your email as a record of the device that was checked out to you in the event that the device is lost, stolen, or damaged. Students can also log in to the District's Asset Management System: IncidentIQ to check on any asset assigned to them.
