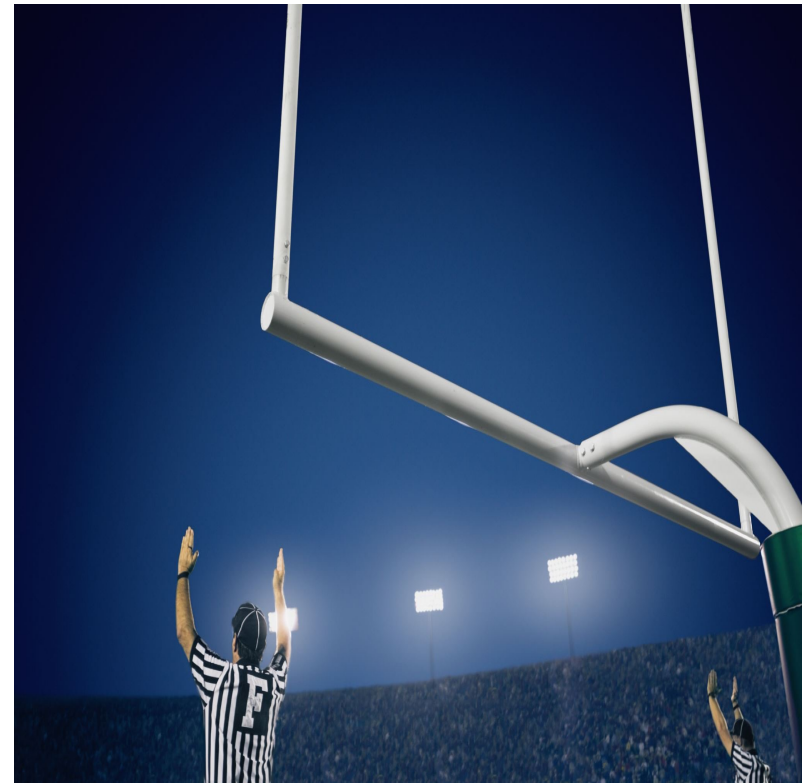

Maintain 90% or higher proficiency in all areas – high school ELA, Algebra, Geometry, Biology, US History, Civics.

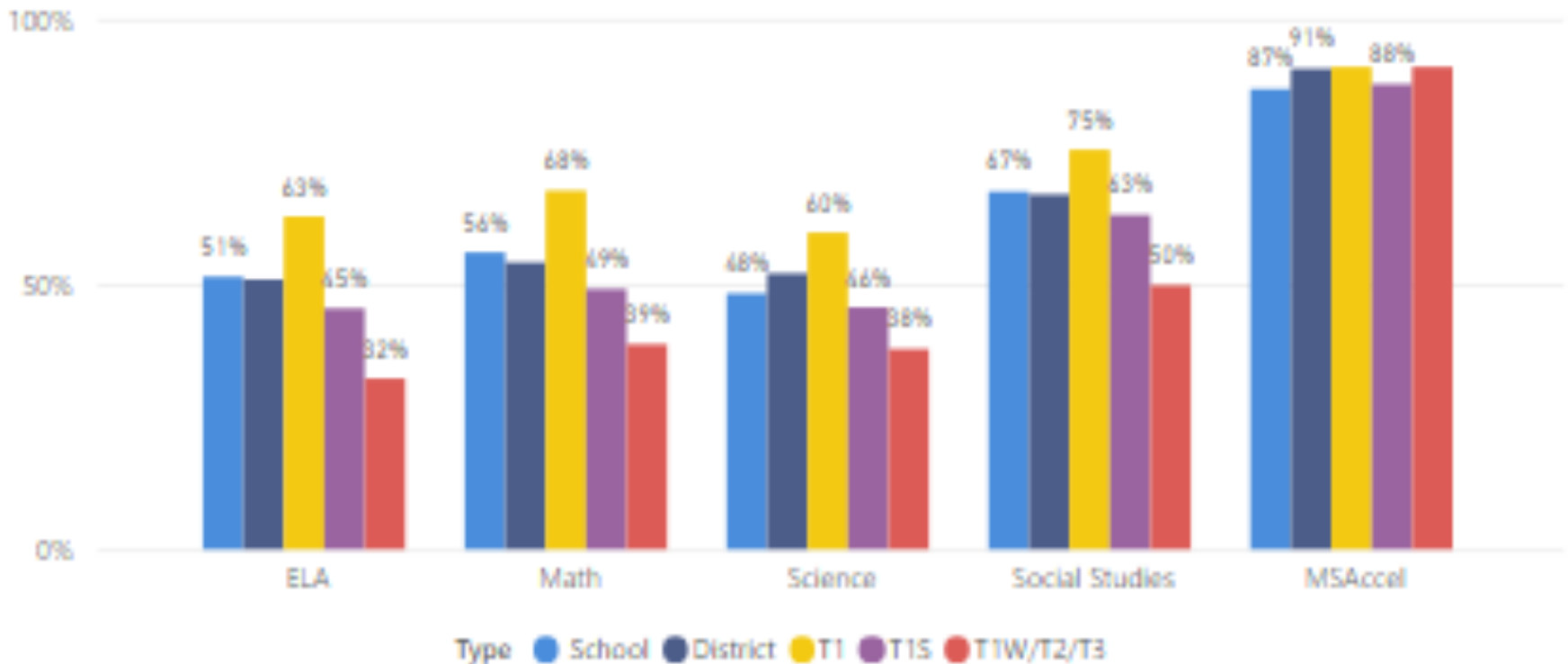
Improve middle school Language Arts scores to cross over the 90% proficiency threshold. Currently, they are within 85-88%.
